1. Tables will not be bigger than 8ft in length. Most likely 6ft.
2. Exhibit area is limited to one table space provided. Vendors who use racks or other display devices which are not set up on the display table will need to purchase additional space.
3. All exhibits shall be set up no later than 5:00 pm on Friday May 4, 2012 and shall remain set-up until 4pm Saturday May 5, 2012 unless prior arrangements have been made.
4. **Please be advised we will not have access to power outlets or internet.**
5. Maximum of two (2) exhibit spaces per exhibitor. Unless arrangements made in advance in writing.
6. CID reserves the right to prohibit the exhibit of items that are not appropriate and/or conflict with the organization and event purpose.
7. CID will be raffling off prizes. We strongly urge exhibitors to donate raffle prizes for more exposure for your business. CID will need these raffle prizes by May 4, 2012 we ask that the donation be no less than \$20 in value.
8. CID recommends you provide items for our welcome bags, items of your choice but must be delivered to address below by April 15, 2011 or items will not be included.
